Michigan Association of Health Plan members rank among nation's best

National Committee on Quality Assurance Report highlights excellence of Michigan health plans

Lansing, Mich. – Michigan Association of Health Plans (MAHP) member health plans were once again rated among the best in the nation, according to the independent 2015-2016 National Committee on Quality Assurance (NCQA) Health Insurance Plan Rankings.

For Medicaid plans, the following MAHP member health plans were rated 4.0, considered high performing: Molina Healthcare of Michigan, Meridian Health Plan of Michigan, Priority Health, UnitedHealthcare Community Plan and Upper Peninsula Health Plan. These plans were rated among the best in the nation.

For Medicare, Health Alliance Plan of Michigan, Paramount Care, Priority Health and UnitedHealthcare Insurance Company were rated 4.0, considered high performing.

For commercial health plans, MAHP members Grand Valley Health Plan (rated highest in Michigan), Health Alliance Plan of Michigan, Health Alliance Plan of Michigan (HealthPlus) and Priority Health were all rated high performing.

This rating methodology is in its second year used by NCQA, Health Insurance Plan Ratings 2015-2016 for private, Medicare and Medicaid health insurance plans are based on their combined HEDIS® (audited performance measures on health metrics), CAHPS® (consumer satisfaction scores), and NCQA Accreditation. This methodology uses a similar system of quality ranking as the federal Centers for Medicare and Medicaid Services Five-Star Quality Ranking Systems used for the Medicare program, with health plan scores from 1-5 in 0.5 increments.
